


## EXPAND

## DEFEND

IP law is a constantly evolving discipline. With every new case, alongside our clients, we help shape a bold and protective body of case law before Europe's leading specialist IP courts and tribunals.

Below are a few of the most notable IP cases we handled with our clients in 2025.

- **Syngenta v. Sumi Agro** (UPC Court of Appeal – 2025/12/19): Very important victory for our client Syngenta, a leading crop protection company, in a landmark decision on the file inspection applications before the Court of Appeal of the Unified Patent Court.
- **Sol IP v. BYD and other EV manufacturers** (UPC The Hague Local Division / Munich and Mannheim Regional Courts – 2025): Successful representation of 4G standard-essential patent owner against various car manufacturers in seven infringement litigations before the Munich and Mannheim Regional Courts and the UPC (The Hague Local Division); all cases settled favourably at an early stage in the course of 2025.
- **Rio Tinto Alcan International Limited v. Trimet Aluminium SE** (EPO Enlarged Board of Appeal – 2025/04/07): Successful decision for Rio Tinto Alcan International Limited before the EPO Board of Appeal, resulting in the full revocation of European Patent EP 3266904.
- **Biogaran v. Bayer** (Paris Court of first instance – 2025/07/11): Successful defense of Biogaran against Bayer in infringement proceedings.
- **Monster Energy Company v. Kronenbourg (formerly Onyx)** (French Supreme Court – 2025/11/13): Successful decision before the French Supreme Court in a trademark enforcement matter: prior EUTM REFRESH THE BEAST! and HYDRATE THE BEAST! against French TM app. LA BETE.
- **Châteauneuf-du-Pape and INAO v. Royal Wine Corp and others** (Order of the pretrial judge, Paris Court of first instance – 2025/03/19): Successful preliminary decision for Châteauneuf-du-Pape and INAO. The Paris Court decided that the action is not prescribed. A decision on the merits is expected in 2026.
- **Sanofi v. Bharat Biotech** (EUIPO Board of Appeal – 2025/11/10 [2 decisions] / EUIPO Cancellation Division – 2025/03/21): Successful opposition decision for Sanofi before the EUIPO that decided that there is a likelihood of confusion between prior EUTM Reg. COVAXIS for vaccines and EUTM BCOVAXIN and COVAXIN BHARAT BIOTECH.
- **Spéciales Gillardeau v. SARL Anthony Hautemaniere** (Order of the President, Paris Court of first instance – 2025/12/09): Successful infringement seizure for the Gillardeau oysters just before Christmas!
- **Leroy Merlin v. SAS Richardson** (Marseille Court of first instance – 2025/10/02): Successful defence of Leroy Merlin (Adeo Group) in trademark infringement proceedings resulting in the dismissal of all claims brought by Richardson in relation to the sign "EASY".
- **Bureau National Interprofessionnel du Cognac (BNIC) – oppositions based on the COGNAC geographical indication** (French IPO – 2025/03/11 [v. TI'GNAC] / 2025/12/30 [v. APERO'GNAC]): Successful recognition that the term "GNAC" constitutes an unlawful evocation of the geographic indication COGNAC, both in relation to similar products (TI'GNAC) and to dissimilar products and services (APEROGNAC).
- **Spotify AB – oppositions based on the SPOTIFY and/or HEY SPOTIFY trademarks** (French IPO – 2025/06/30; 2025/08/04; 2025/08/11): Three victories for Spotify in oppositions against the trademarks SPOTE, SPOTIFY and LE SPOT.
- **Bal du Moulin Rouge v. litigious domain names** (WIPO – 2025): Twelve victories for Bal du Moulin Rouge in UDRP proceedings in 2025, achieving a 100% success rate.



## STAND OUT

In 2025, we were honored to be once again recognized by the profession through several major awards.

At the Managing IP Awards 2025 ceremony in London, CASALONGA received three top-tier distinctions: France IP Disputes Firm of the Year, France Trademark Prosecution Firm of the Year and France Practitioner of the Year, awarded to Caroline Casalonga.

Additionally, eight CASALONGA Partners have been included, once again, in the Best Lawyers rankings for their distinguished practice: Caroline Casalonga, Arnaud Casalonga, Floriane Codeville, Karina Dimidjian-Lecomte, Marianne Gabriel and Pascale Vincent in France, Cristina Bercial-Chaumier in Spain and Benjamin Grzimek in Germany.
